Old Business:

- Website was updated
- Opened a savings account for unused funds. High Yield Savings Acct for 3.5% (business savings account)
- Cleaning crew came on February 17th and will be coming monthly/bimonthly (when needed)
- Gas Tank : Company is coming to repair the tank on March 26th, it will cost \$400.
- Hunter Safety was given the carport outside but they never took it so they said we could have it back. We are moving the carport down to the pistol range on the left hand side on the 50 yard line for use.
- High School is building two gun racks and two picnic tables – this was voted on through email.
- We brought in dirt to fill the sidewalk.
- Lights were all changed on the Range.
- Grass Seed, straw, fertilizer, etc was purchased to grow the grass.

All in favor of new members – Sheriff made a motion to accept, Jason seconded it. Motion carried.

Discussion of Fundraisers:

- A turkey shoot/bowling pin shoot was mentioned.
- Foster brought up having a golf ball shoot
- Haynes said he would speak to Stutts about the method of doing the shoot.
- A contact name was given to assist in achieving bowling pins if we decided to do a bowling pin shoot (Gary Golden)
- Stutts asked about moving the meetings to a later time so SRO's could attend. It was decided we could not necessarily do that because, not only is there really only two SRO's who would attend the meetings (Stutts and Snow), but those of us who have children would not be able to wait until after school got out to have a meeting that has a potential to run for an hour-2 hours in time.
It was brought by Major Gary Zickmund up to possibly make the meetings around Teacher Work Day's which could assist in fixing the problem of the SRO's not being present.
- It was brought up to get a grill to be able to grill out for meals during the meetings and for individuals who rent out the range to use. Colt made a motion to buy a nice blackstone and Matthews seconded it. However, it was brought up to buy a grill at the Pawn Shop in Clemons because they are cheaper there. It was also brought up that we do not have to get a very expensive one, due to that many individuals using it, it may get messed up if people do not follow directions.
- Someone asked about how much money we have saved up for Shop With A Cop for the 2025 year. We only have \$1,624 saved so far. The next fundraiser will be to raise money for the Law Enforcement Association.
- Hunter Ed wants to put power on the building out back to put heaters and lights outside. It will be free to the range because one of the students parent will be doing the work. Shuskey made a motion to accept this and Daniel Matthews seconded the motion. It was approved.
- The water department needs to get into the range to do testing once a year. So, we were informed that when we change the codes to the door, gate, alarms we need to let the water department know those new codes so they know how to get in. Two names were given for this **Andy Atwood** and **Johnny Lambert**. They both work for the County Water department.
- We need to decide on a date we are going to be painting inside the range and doing the pressure washing outside of the range. Butero got the paint for us for free but they will not hold it for us forever. He needs to know when he needs to pick it up depending on when the job is going to be done. The boy scouts volunteered to help so we need to make sure they are good for those days when we choose them. We need to also make sure we have enough pressure washers and see how many spickets we have on the building so we can get that done in a timely manner.
