Old Business:

Meeting 6/26/2024

- Camera System
 - Monthly subscription (free 30 days, live feed, \$120 a year)
 - Motion was made to buy the subscription, seconded, carried
- Keypad for front door
 - Have been purchased from Lowes for front door and office.
 - Man coming at 2:00 PM August 28th
 - Range master- code for alarm
 - Make sure to turn the security alarm off after entering the building with the new passcode
- Website
 - Haynes showed the website and said he is planning to add photos of the range and things we have done like shop with a cop.
- Concrete/dirt filled in at the range
- Amendments to the bylaws
- Flooring
- Stove
 - Next week, Haynes said someone is coming out to clean and add a regulator to the stove.

New Business:

-Matthews asked about bringing individuals to shower at the range from a church. He was told to contact other churches first about showering there instead.

-Website

When speaking about the new website it was brought to Haynes attention by the Sheriff about some things that should be added to the website. That list is as follows:

- The range rules
- The amended bylaws
- Concealed carry signup
- Schedule of who has reserved the range and when
- Shop with a cop
- Contacts

The website is DCLEA.org

Other suggestions included adding that it is not a public range and to use the range one must be sworn law enforcement.

Matthews also brought up how much he charges for the concealed carry classes.

-Changing the gate code

We need a list of everyone who uses the range

Sheriff made a motion to change the gate code, Matthews seconded the motion

New gate code: 6238

-Concrete at the range

An advanced masonry class is coming out to do the job for free, we just have to get the supplies to do the job.

Colt recommended getting a handicap accessible parking pad to fit a van put in and hanging up the handicap parking sign because it is something we are supposed to have anyway.

-Amendment to the bylaws to be able to vote through email was finished by the Sheriff.

Bylaws are being rewritten by Rebecca.

-Flooring

We need a letter with DCLEA letterhead formally including what we need to do the vinyl plank on the floor.

Butero is writing the letter and getting it to Haynes to sign.

Butero needs the exact measurements and preferred color of flooring and can possibly get it donated to DCLEA.

It was also brought up that he will need help laying the floor – need volunteers

-A motion was made to get the areas around the range cleared out with a bush hog by Colt, seconded by Matthews

Joe Crotts said he is happy to do it for free.

-It was also brought up that the kitchen needs some help, Velotta and Rebecca are going to research some cleaning companies around Davie County to hire for that.

-Shuskey mentioned that the “range lights suck”

A flood light was recommended to get installed outside

Replace the lights that are there with LED or can lights

A switch needs to be added to the building for the lights

Need to get companies out there to price new lights – field lights

LED solar lights were also mentioned as an option

Need new lights because of the safety aspect

Make sure to have a switch or remote added for access to the lights

Need to contact electricians for the job, energy united was an option

-Colt brought up that he patched the water heater and we need a new propane water heater soon, he patched the roof, need a new roof soon

-New propane tank- Matthews contacted people he said we can rent it for the year. Colt said the tank we have has a bad valve.

Joe Crotts said Zach Privette replaced his (phone number is 336-909-0495)

We agreed to get prices up to \$500, make sure they pressure test before anything

The Sheriff made a motion to fix the gas valve issue, Shuskey seconded, motion carries

-Fixing the stove

-Shop with a cop
